Hosting Department's Acknowledgement of Responsibilities

The purpose of the J-1 Exchange Visitor Program is to implement the Mutual Educational and Cultural Exchange Act (Fulbright-Hayes Act) of 1961. This Act seeks to increase mutual understanding between the people of the United States and the people of other countries by means of educational and cultural exchange and to promote international cooperation for educational and cultural advancement between the United States and other countries.

To this end, the U.S. Department of State expects hosting institutions to provide exchange visitors with an environment and activities to facilitate such cooperation, and ensure the well-being of the exchange visitors during their stay (22 C.F.R. Part 62).

- 2. The department will provide the visiting scholar an adequate work environment to conduct his/her exchange activities at UConn. This includes, but is not limited to, office and laboratory space, equipment and administrative support, access to UConn resources (NetID, UConn ID card, library, etc.) and the availability of the hosting faculty member for the visiting scholar.
- **3.** The faculty sponsor will provide or make available to the visiting scholar and their accompanying family members a variety of appropriate cross-cultural activities. These activities may promote exposure and interchange between visiting scholars (and their families) and Americans so as to increase their mutual understanding of each other's society, culture and institutions (22 C.F.R. § 62.8(d)).
- 4. The department is required to submit an annual report to ISSS on efforts that promote exchange reciprocity within the department, and on cross-cultural activities provided to the departments' visiting scholar(s). This information will, in turn, be reported by ISSS to the U.S. Department of State in UConn's Exchange Visitor Program Annual Report.
